### Family Membership Questions & Answers

*1. When can we start purchasing Family Memberships?*

You may start purchasing Family Memberships immediately.

*2. What is the proper procedure to obtain the Family Membership rates for my family?*

- A. Properly complete and sign the normal annual membership form for EACH family member
- B. Please ignore the membership rates on the annual membership form. Please refer to the Family Membership Rate Table (page 2)
- C. Submit to the USJF National Office:
  - 1. ALL completed and signed annual membership forms
  - 2. Family Membership Application form (page 3)
  - 3. Family Annual Membership Fees (page 2)

*3. How do I enroll my family online?*

We are in the midst of overhauling our membership processing system and website. **At this time, our online system does NOT allow for processing/enrolling Family Memberships.** The capability to process Family Memberships is a planned addition to the online membership system for 2020. In the meantime, we will process Family Membership using the procedure described in item #2 above and this form (see page 3).

*4. Who are considered to be family members that qualify for the family rate?*

Family members are dependents living in the same household with their parent(s) or legal guardian(s), or not co-located but are legally claimed as dependents for tax purposes.

*5. I am a USJF Life/President's Club Life Member. Do I qualify for the Family Membership Rate?*

Since Life members already receive discounted membership rates, they are not eligible to participate as part of the family rate. Life Memberships with discounted rates cannot be combined with the Family Membership Rate for additional discounts.

*6. I am a USJF Joint Member. Do I qualify for the Family Membership Rate?*

Since Joint members already receive discounted membership rates, they are not eligible to participate as part of the family rate. Joint Memberships with discounted rates cannot be combined with the Family Membership Rate for additional discounts.

*7. What is the duration and expiration of the Family Membership?*

All Family Memberships are for one (1) year. Short-term memberships are NOT offered with the Family Membership. The Family Membership for everyone in the family will have the same expiration date.

### Family Membership Questions & Answers - Continued

8. *We already purchased a Family Membership. Is it possible to add additional family members later?*  
Yes, you may add additional family members using the Family Membership rate if you submit properly completed and signed annual membership form for each new family member(s) and pay the additional Family Membership difference. It is important to note that the expiration date for memberships for the new family addition(s) will be the same as the rest of the family's initial enrollment expiration.

For example:

- The Happy Family starts judo at the Acme Judo Dojo and obtains USJF Family Membership for their five (5) children: Grumpy, Happy, Sleepy, Bashful, and Sneezzy on February 15, 2019
- The Happy Family pays \$200 (see Family Membership Rate Table for 5) for their Family Membership
- The memberships for the family will all expire on February 29, 2020
- In June, Dopey and Doc decide to do judo with the rest of their family members
- Thus, the Happy Family adds Dopey and Doc to their family membership by submitting:
  - Updated Family Membership form
  - Completed and signed membership forms for Dopey and Doc
  - \$60 additional Family Membership fee payment for Dopey and Doc = \$260 seven member family fee - \$200 five member family fee = \$60 additional Family Membership fees due
- There is NO PRORATION on additional the Family Membership fee for the late family members added to an existing Family Membership
- Dopey & Doc's membership will expire on February 29, 2020 too

9. *I have more than six members of my family, what is the correct Family Membership Fee?*

For each family member greater than six, please add \$35 per person. Thus, seven would be \$230 + (1 person X \$35) = \$265. \*\*\*Add additional copies of page 3 as needed\*\*\*
