RE: FY 2021 USJF Dojo/Club Registration Fee - WAIVED

DATE: September 15, 2020

Hope that everyone is managing to stay safe and healthy during these difficult times.

The USJF Board of Directors has waived the USJF dojo/club registration fee for Fiscal Year 2021 (9/1/2020-8/31/2021). You do not have to pay the USJF portion of the dojo/club registration fee (\$25). Please check with your yudanshakai regarding your yudanshakai's dojo/club registration fee to see if they are making any changes/adjustments in their dojo/club registration fees for FY 2021.

To be a registered member dojo/club of USJF, you <u>MUST submit a completed USJF Club Registration & Insurance Application (USJF form 509)</u> and the appropriate fees. If you do not submit the completed form & fees, you are not a properly registered USJF dojo/club.

The USJF Club Registration & Insurance Application Form MUST be submitted with the proper fees. **Please remember, your dojo/club and members do not have insurance coverage until it is properly registered with USJF.** Please submit your USJF form 509 as soon as possible.

An important reminder, dojo/club registration are due on September 1 of each year. Dojo/club registrations are a fixed year that starts on September 1, to August 31, of the next year. To ensure continuous insurance coverage, you must renew your dojo/club registration on or before September 1 each year. Not doing on-time makes for a lapse in the insurance coverage for your dojo/club. The lapse starts on September 1, and lasts until the dojo/club is properly registered. The new Fiscal year 2021 started on September 1, 2020, and runs through August 31, 2021. If dojo/club is not already registered for FY 2021, any dojo/club activity is currently occurring at your own and their own risk as there is no insurance coverage for anyone since the dojo/club is not properly registered.

With regard to those dojos/clubs that require a certificate of insurance for your facility, <u>your dojo/club MUST be properly registered</u> with USJF before a certificate of insurance can be issued for your dojo/club.

We encourage you to plan ahead and get everything in-order before you need them.

We realize that many/most dojos are closed and/or prohibited by public health edicts/guidance to ease operations, we encourage you to get your dojo/club registration in now. It puts you in position for quick/immediate start up when the opportunity presents itself.

Also, certificate of insurance processing is not instantaneous. It has to be reviewed and approved by the insurer. Generally, we allow for 3-days of processing, AFTER we receive the request. This assumes that the dojo/club is already properly registered. If the dojo/club is NOT properly registered, this will add additional time/delay in the processing and issuance of the certificate of insurance. We do not submit certificate of insurance request to the insurer until the dojo/club is properly registered.

Some important information below, depending on your current situation...

- I. Your dojo/club registration form and fees have already been submitted thank you!
 - a. You should be all set
 - i. If the USJF registration fee was included, we will refund the USJF portion of the dojo registration fee back to the payer
 - ii. If the yudanshakai registration fee, as usual, USJF will forward the yudanshakai portion of the dojo registration fee to your yudanshakai
- II. You have not yet submitted your dojo/club registration form and fee(s) please do so IMMEDIATELY!
 - a. Your dojo/club and students are <u>NOT currently covered by USJF insurance as your dojo/club is not currently properly registered as a USJF dojo/club. Any activities that are currently occurring at everyone's own risk.</u>
 - b. Please submit your dojo/club registration form and fees as soon as possible.
 - i. If you submit with your yudanshakai registration fees
 - As normal, USJF will forward the yudanshakai portion of the dojo registration fee to your yudanshakai
 - ii. If you submit with both USJF and your yudanshakai registration fees
 - 1. USJF will refund the USJF portion of the dojo registration fee back to the payer
 - 2. As normal, USJF will forward the yudanshakai portion of the dojo registration fee to your yudanshakai
