Proposed USJF/USJA Joint Statement

To: USJF and USJA Members
Re: USA Judo notification of “Your Choice” Participation/Membership Plan with No Insurance Participation Waiver

Members have raised questions regarding USA Judo’s recent announcements concerning the “Your Choice” Participation/Membership Plan with No Insurance Participation Waiver. In this Joint Statement, the USJF and USJA (hereafter the Parties) explain our positions on this issue.

Based upon our current understanding, the Parties are extremely concerned with the additional liability placed on our members if they participate in a USA Judo event with the “No Insurance Participation Waiver” option and sign a waiver to that effect. We have the following concerns:

1. The USA Judo announcement does not address the fact that under their new position, neither Parties’ insurance coverages follow the Parties’ members to USA Judo events. This means that any Parties’ members who participate in USA Judo’s “No Insurance Participation Waiver” program do so with only their own personal insurance coverage, if they have it, or none at all.
2. Furthermore, assuming that USA Judo has not made any additional changes to their insurance policies, the warranty requirements for the liability and secondary participant accident insurance coverages mandate the following:
 - a. At USA Judo events, all participants must have participant accident insurance coverage from USA Judo. As USA Judo no longer accepts or recognizes either Parties’ insurance coverages, they may be violating the requirements of their own policies with this “No Insurance Participation Waiver” membership.
 - b. The “No Insurance Participation Waiver” will be required for either Parties’ members to participate, again violating the insurance warranty requirements.
3. Because the “No Insurance Participation Waiver” appears to be a tool to discourage lawsuits and other related problems, we do not think it sufficiently addresses the warranty requirements for the insurance policies.
4. Also, the “No Insurance Participation Waiver” does not necessarily waive any individual’s rights to sue for whatever reason that they choose, regardless of the signing of such waiver.
5. The “No Insurance Participation Waiver” program appears designed to lead the Parties’ members to assume that the Parties’ insurance coverages will follow them to the USA Judo events. **They do not.**
6. USA Judo may have negotiated changes in the warranty requirements in their insurance policy(ies) in the middle of the policy year. We do not know if this has or has not occurred. If it has occurred, we find this a very rare and unusual occurrence. Concerned individuals may consider contacting USA Judo for more details about any changes to USA Judo insurance coverages.

The Parties' position is that we strongly do **not** recommend our members to sign any "No Insurance Participation Waiver."

Please remember that the Parties have signed a reciprocal agreement to recognize each other's members at our sanctioned events. Both Parties' members receive the same insurance coverage as before and are mutually welcome at our events.

And please also remember that both the Parties have short-term, discounted rates for membership. We encourage all USA Judo members to take advantage of these discounted rates before they expire.
