Reminders:

- ALL candidates for office must be nominated by a member (delegate) of the Board of Directors.
- A second for the nomination is **NOT** required.
- The Nominee **MUST** either: be present to accept the nomination or have agreed prior to the meeting to accept the nomination and serve in the position if elected.
- Normally, the election is conducted as a separate vote/election for each individual office.
- In the specific situation when there is only one (1) nominee for each office, the vote may be conducted as a slate since all of the offices are **UNCONTESTED**.

V. USJF Endowment Fund Trustees

A. Corrections due to a recent review of the USJF Endowment Fund by-laws

- i. We have been using the name, "Endowment Trust" incorrectly
 - 1. The USJF Endowment is a trust.
 - 2. The proper and formal name is, "United States Judo Federation, Inc. Endowment Fund".
 - 3. The approved shortened version is: "USJF Endowment"
 - 4. We should start using the correct nomenclature (s) and refer to our trust as "USJF Endowment"
- ii. Incorrect terms of service for the Trustees
 - 1. Initially, the USJF Endowment started with 2 different lengths of terms for the Trustees
 - a. 2-Year terms
 - b. 4-Year terms
 - c. We continued to alternate 2 & 4 year terms so that there has always been either 2 or 3 of the Trustees continuing for 2 more years in pursuit of some continuity of planning.
 - 2. With the recent review
 - a. After the 4th year of the founding of the USJF Endowment, all successive terms should have been 2-year terms for all 5 trustees
 - b. We have been incorrectly using the staggered formula with a mix of 2-year and 4-year terms
 - c. Therefore, All Trustee Terms Are Expiring At This Meeting
 - 3. Starting with this year's Trustee election, all 5 Trustees will have 2-year terms
 - a. All of the outgoing trustees are eligible for re-election
 - i. Keith T. Chu (Nanka)
 - ii. Bert A. Mackey (Northwest)
 - iii. Bryan J. Matsuoka (Daiheigen)
 - iv. Dr. Richard S. Nakatsu (Hawaii)
 - v. Thomas J. Sheehan (Konan)
