1-Item Agenda:

- Elect one (1) member to fill vacant seat on the National Promotion Committee
- **This vote is to FILL GREEN ELECTED SEAT #11.**
- Nominee must be from an UNREPRESENTED yudanshakai. Thus, must be from one of the following yudanshakais: Central Coast, Chicago, Chuka, Florida, Florida State, Ganbaru, Hudson, Makoto, Pacific Southwest, Rokushu, San Joaquin, Shinnanbu & Southern Pacific
- Additional requirements are:
 - must be BOE delegate for their yudanshakai
 - must have recognized Judo rank of Godan or higher
- Presidential Appointment seats #12 & #13 will be filled by the President after the election.
