Introduction to USJF Charter Club Scholarship Program

The objective of the USJF Charter Club Scholarship Program is to foster a strong partnership among the USJF, Charter Club Sensei and their students.

The USJF Charter Club will have the opportunity to recognize and award scholarships to both competitor and non-competitor members who continue to strengthen their communities by embodying the Judo values of friendship, honor, courage, self-control, humility, respect, and perseverance, ultimately becoming exemplars of Champions of Character.

Fund Distribution; USJF Charter Club Scholarship Program

Funding is given once a year, June of the current fiscal year. The funding amount is dependent on the current USJF total membership and total USJF members within the USJF Charter Club.

In an effort of transparency, funding amount will be posted every year showing the USJF Charter Club membership total and the amount awarded. Funding is provided directly to the USJF Charter Club, which is responsible for distributing the funds to its dojo membership.

The USJF Charter Club Sensei may submit, along with photos, the names of individuals who have received dojo scholarships to be featured on the USJF website.

Eligibility; USJF Charter Club

Current USJF Charter Club (with a minimum of 10 members) are eligible, provided that the USJF members within the club have maintained their membership for at least 10 months. Dojo members must be registered with the USJF for a minimum of 10 consecutive months to be included in the Charter Club membership count.

USJF Scholarship Committee

The USJF Scholarship Committee will oversee the strategy, long-term planning, and application process.
