5. Yudanshakai Membership For Vote Count DEADLINE TUESDAY, MARCH 31, 2026

The registration deadline for the purposes of vote count determination is **Tuesday, March 31, 2026.** Registrations must be submitted with all fees & received by the National Office by this date. (article IV, section 2.B)

6. Committee Report/Minutes DEADLINE: MONDAY, APRIL 13, 2026

All committees should submit their written reports/minutes to the National Office as finished documents in PDF format on or before the deadline. Documents will be uploaded to BOE/BOD page for downloading by meeting delegates.

7. BOE & BOD YDK Delegate Roster Submission DEADLINE: MONDAY, APRIL 6, 2026

All Yudanshakai Presidents should submit delegate rosters via email to usjfed@usjf.com.

• **Elections**

Example:

1. This May 2026 BOD is an election meeting. **PROXIES ARE NOT PERMITTED.**
2. Yudanshakai delegates must be present to be able to exercise all of your yudanshakai's votes.
3. For example: ABC Yudanshakai has 3 delegates with 1 vote per delegate.
 - A. Proposal completes discussion and discussion is closed.
 - B. Voting commences
 - C. Delegate1 – votes, “yes”. Delegate2 - leaves the room to get coffee. Delegate3 – votes, “yes”.
 - D. Voting closes.
 - E. Delegate2 returns with coffee after voting has concluded.
 - F. ABC Yudanshakai exercised only 2 votes, because Delegate2 was **NOT PRESENT DURING VOTING AND DID NOT VOTE.**
 - G. **Delegate must be PRESENT to vote.**
